
2. Financial and bookkeeping matters, including payment of the bills and review of investments.

4. Travel Reimbursement Guidelines and Director expenses for conferences.
5. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
6. Operation of District facilities, repairs, and maintenance, including:
 - a. FEMA reimbursement claims;
 - b. repairs to LJ Parkway at levee crossing;
 - c. proposals for hog control; and
 - d. mowing.
7. Critical Load Spreadsheet and filing of same.
8. Fort Bend Flood Management Association and Regional Perimeter Levee matters, including:
 - a. state and federal legislative and regulatory matters;
 - b. update on USACE perimeter levee inspection; and
 - c. Fort Bend County Municipal Utility District No. 46 levee improvements.
9. Stormwater Management Plan, including public comments and conduct training.
10. Amended legal services agreement.

Construction Items:

11. Engineering matters, including:
 - a. authorize design of projects in the service area;

- b. approve plans and specifications and authorize advertisement for bids for construction projects in the service area;
 - c. review bids, award contract, and authorize execution of letter financing agreement and cost sharing agreements, if applicable, for projects in the service area;
 - d. approve pay estimates and change orders and final acceptance as appropriate for projects in the service area, including:
 - i. Detention for The Grove;
 - e. update on surplus funds application;
 - f. Permit for Construction of Facilities in Levee Right-of-Way;
 - g. deeds and easements and consents to encroachment; and
 - h. requests for annexation.
12. Park and recreational facilities matters, including:
- a. approve plans and specifications and authorize advertisement for bids for projects in the service area;
 - b. review bids, award contract, and authorize execution of letter financing agreement for projects in the service area;
 - c. approve pay estimates, change orders and final acceptance for District projects, including:
 - i. Hagerson Linear Park; and
 - ii. LJ Parkway Phase 8; and
 - d. park and recreational facility maintenance agreement.
13. Development in the District, including:
- a. description of section development, lots sales and home building activity; and
 - b. Financing Agreement and developer reimbursement matters.
